GENERAL TERMS AND CONDITIONS OF QUOTATION

1. There is no separate Tender form for this tender other than "Supplier Registration Form". Data provided in Tender's Techno Commercial documents should cover all fields/conditions mentioned in this form
2. QUOTATIONS will be opened in Meeting of Purchase committee at the time of opening of the tenders.
3. Terms & Condition of supply should invariably be indicated on the schedule which otherwise would be taken on its face value.
4. The rates quoted should be inclusive of all charges as far as possible along with the rates of necessary consumable spares. The percentage of tax (es)/duty (ies), if any, should invariably be mentioned separately. If no VAT/Sales Tax is chargeable, rates should be quoted as Net.

5. The rate for Annual Maintenance Contract with and without parts will invariably be indicated and quoted along with his offer. The contact person and address that will provide maintenance should be indicated.
6. The offer must be clearly filled in ink legibly or typewritten giving full address of the Tenderer. The offer should be signed by the offerer himself/themselves or his/their authorized agent on his/their behalf (authority letter be enclosed with the application).
7. The offerer should make sure that the rates quoted are written in such a way that interpolation is not possible. No blanks should be left which would otherwise make the tender rejected.
